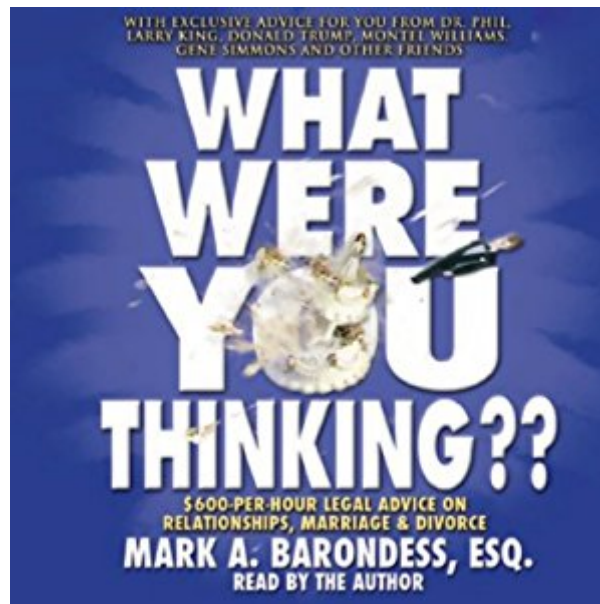

The author tends to engage in conjecture at times, but overall, his book is very insightful on the divorce process and it definitely makes one realize all the practical implications of a marriage.
